Dear Mr. Kee:

Thank you for responding to the April 17, 2009, letter regarding the making of a grant by the Commodity Credit Corporation (CCC) to the State of Delaware based on assistance authorized by the American Recovery and Reinvestment Act of 2009, to assist aquaculture producers for losses associated with high feed input costs during the 2008 calendar year. Enclosed are two originals of the grant agreement between CCC and the Delaware Department of Agriculture that must be executed by an appropriate official of the State of Delaware, as a condition for receiving the grant. Please return both signed originals to CCC by June 10, 2009, so the grant funds can be advanced to your State.

We have enclosed the following documents that must be executed by the State and returned with the two signed original grant agreements:

- Form SF-424B, "Assurances - Non-Construction Programs," as authorized by Office of Management and Budget Circular A-102, "Grants and Cooperative Agreements with State and Local Governments."
- Certification Regarding Lobbying, as required by 7 CFR Part 3018, New Restrictions on Lobbying.
- Standard Form-LLL, "Disclosure Form to Report Lobbying," as required by 7 CFR Part 3018, New Restrictions on Lobbying.

Please note that item E1 of the enclosed agreement requires the State to provide CCC a work plan providing a summary of how the State will implement the 2008 Aquaculture Grant Program, including, but not limited to, a copy of the State's application form, 2003-2007 5-year average feed price established by the State, required documentation, and the State's methodology for conducting internal reviews of the program. Advancing grant funding to the State is contingent upon CCC's approval of the State's work plan. Therefore, please submit your State's work plan to CCC as soon as possible. 

6. If the total amount of benefits calculated in item C4, after applying the payment limitation in item C7, for all eligible applicants in a State exceeds the grant amount provided in item C2, the State shall reduce the amount of assistance calculated for each applicant on a pro rata basis.
7. The total amount of assistance that a person may receive from the funds made available under this and any other state's Agreement for this program shall not exceed \$100,000 in aggregate, except for general partnerships and joint ventures in which case assistance shall not exceed \$100,000 times the number of members that constitute the general partnership or joint venture. The rules of 7 CFR Part 1400 shall apply to "person" determinations (the rules for attributing payments in addition to the owners of entities and sub-entities will not apply). 7 CFR Part 1400 is available at www.access.gpo.gov/nara/cfr/waisidx_04/7cfr1400_04.html. The payment limitation shall be applied to an applicant based on the applicant's business structure as it existed during calendar year 2008.

Likewise, no person shall be eligible to receive assistance if their adjusted gross income, as computed under 7 CFR Part 1400 with respect to 2008 programs, averaged more than \$2.5 million for calendar years 2005-2007.

D. PROVIDING ASSISTANCE

In the provision of assistance under this grant Agreement to eligible aquaculture producers:

1. Application procedures for 2008 aquaculture feed funds will be as determined by each State.
2. Assistance may be provided by the State to eligible aquaculture producers using one of the following methods:
 - a. Provide cash payments directly to eligible producers; or
 - b. Provide assistance in the form of feed credits, vouchers, or similar instruments to be applied to future aquaculture feed purchases.
3. Assistance shall only be provided to an eligible aquaculture producer that:
 - a. Produced an aquaculture species for which 2008 feed costs represented at least 25 percent of the producer's total input costs for the aquaculture operation, as certified by the producer;
